

Minutes from September Meeting

**Burnet County Republican Women PAC
Minutes of General Meeting – September 12, 2019
Sylvester H. Reed Memorial Building – Burnet, Texas**

Call to Order and Opening Ceremonies: President Kay Stripling welcomed the huge turn-out to the Fall kick off meeting of the BCRW at 11:30. She invited speaker Sheriff Calvin Boyd to lead the service line and thanked caterer Kevin for the special lunch. The general meeting was called to order by President Stripling at 11:50. She shared news with attendees that, although the BCRW did not meet over the summer, the club participated in many activities: A booth at Main Street Market Days in Marble Falls in June and both a booth and float at the Oatmeal Festival in August. She thanked Londa Chandler who spearheaded these events; Londa was given a big round of applause in appreciation. Those who worked on the events were asked to stand and were given a round of applause. Also, on September 8th the BCRW partnered with the BCRC to hold a picnic fundraiser with Lt. Col. Allen West at Bill's Burgers in Burnet. Many thanks were given to Amber Cardenas, co-owner of Bill's Burgers (with her husband Max) for hosting the successful event.

Following was the Invocation given by Joe Don Dockery, Precinct 4 Commissioner; Roxanne Nelson, JP Precinct 1 led the pledges to the flags of the USA and Texas.

Recognition of Officials, Guests, and New Members: Elected officials, precinct chairs, and many new members and guests were introduced; especially welcomed and asked to stand were first responders in remembrance of 9/11.

Program: President Stripling introduced Sheriff Calvin Boyd speaking on the topic of border security. Sheriff Boyd shared the horrendous figures of illegal immigration that our border has and is still experiencing. He mentioned the great job the border patrol was doing, despite the enormity of the task they had before them. With so many illegals entering, the patrol is forced to spend their time with intake and managing the intake facilities which leaves the job for which they are trained – border apprehension – serious lacking. He reiterated the fact that Congress is not doing its job. There are no problem solvers in Washington. As a consequence, smuggling of drugs and people continues to be an issue. With the threat of tariffs from President Trump, Mexico is finally helping stave off the flow of immigrants to our border.

Sheriff Boyd told attendees that the border wall continues to be built (construction has never stopped) and is helping curtail the flow. The most frightening thing for Sheriff Boyd and should be for all of us is that there are 11 and 12 year-old children entering the country and our schools. Many of them have been indoctrinated and are members of MS 13. Illegal immigration is still a major problem; Congress needs to do its job and legislate; the Border Patrol needs to be returned to its primary function of border apprehension.

Guest Comments: State Senator Dawn Buckingham followed with information on some of the issues that came before the last legislative session. Two Constitutional amendments will be on November's ballot: 1) Vote to ban permanently an income tax.

If you do NOT want an income tax you need to vote "Yes". 2) Dedicate the sales tax received from the purchase of hunting, fishing, camping, etc. equipment to the State Parks in Texas. They are all strapped for maintenance and operational funding. The Senator also noted that the legislature was doing everything it can think of to keep students safe. She encouraged everyone to "push out" and be involved. She acknowledged the media bias and said to engage it. If we fight hard enough, it can change.

Approval of Minutes: Minutes were approved as published.

Treasurer's Report: Treasurer Carolyn Richmond reported there was a balance of \$12,491.93. Note:

Does not include final deposit and expenses from the recent fundraiser. There is \$1381.09 in the scholarship fund. \$1,000 has not been paid out yet.

Reports of Other Officers and Standing Committees:

- Campaign Activities: Mary Jane Avery mentioned how important it was for members to submit their volunteer hours to her, especially since there had been no meetings during the summer. Their table alone had 300+ hours.
- Membership: Dottie Stueckroth announced we had 6 new members, 12 renewals, 1 new associate, and 1 renewal.
- Caring for America: In Jessica McMurry's absence, Gail Teegarden thanked everyone for the fantastic response to this month's Caring for America project: Providing hand sanitizer for border control agents. Next month's project will be accepting donations for the Highland Lakes High School Republicans Club.
- Fundraising: Kay Stripling spoke of the very successful joint fundraiser with the BCRC at Bill's Burger's. The Chili Cook -Off will be a second fundraiser for the BCRW Scholarship Fund in February. Darlene Hargett will spearhead the silent auction for the event. Darlene needs items for the auction. She also needs volunteers to contact businesses and individuals for donations.

Other Reports:

- Burnet County Republican Chair: Kara Chasteen announced the need for Precinct Chairs; there are 6 vacancies. Also, she mentioned that Senator Dawn Buckingham is having two fundraisers. Information on these events are on Facebook. Lastly, Kara said that she had invited Governor Abbott to the Chili Cook-Off. She was waiting for a response.
- Burnet County Republican Club: Londa Chandler announced the next meeting of the BCRC will be Tuesday, October 1st at the River City Grill. Meeting begins at 6:30. Speaker will be James Dickey.

Announcements: President Stripling announced:

- Next month's meeting on October 10th, our speaker will be Steve Munisteri, former chairman of the Republican Party.
- The TFRW Convention will be held October 3-5. Gail Teegarden, Kara Chasteen, and Janet Crow will be representing the BCRW at the convention. The ladies were thanked for attending.
- Thanks also went to Gail Teegarden and Mary Jane Avery for attending the last meeting of the Highland Lakes High School Republicans and presenting them with copies of the U. S. Constitution. It is great to support the young people as they start this new club.

As there was no further business, the meeting was adjourned at 1:15 pm.

TEXAS CONSTITUTIONAL AMENDMENT ELECTION

Last day to register to vote: Monday, October 7
Monday, October 21 - Friday, November 1
Election Day: Tuesday, November 5, 2019

In Texas, 10 statewide ballot measures are certified for the ballot on November 5, 2019.

PROPOSITION 1:

Allowed to Serve as Multiple Municipal Judges Amendment

Description: Allows persons to serve as more than one appointed or elected municipal judge

A “yes” vote supports this amendment to allow persons to hold more than one office as an elected or appointed municipal judge in more than one municipality at the same time

A “no” vote opposes this amendment, thereby allowing a person to hold more than one office as an appointed, but not an elected, municipal judge in more than one municipality at the same time

PROPOSITION 2:

Water Development Board Bonds Amendment

Description: Allows the Texas Water Development Board to issue up to \$200 million in

bonds

A “yes” vote supports this amendment to allow the Texas Water Development Board to issue bonds on a continuing basis, but not exceeding \$200 million in total principal at any time, for water supply, sewer service, and drainage projects in areas defined as economically distressed

A “no” vote opposes this amendment, thus discontinuing bond funding for the Texas Water Development Board’s economically distressed areas program

PROPOSITION 3:

Temporary Property Tax Exemption for Disaster Areas Amendment

Description: Authorizes temporary property tax exemption for disaster areas

A “yes” vote supports this amendment to allow political subdivisions to provide temporary property tax exemptions in areas that the governor declared as disaster areas

A “no” vote opposes this amendment, thus continuing to allow property reappraisals following disasters but not tax exemptions

PROPOSITION 4:

Prohibit State Income Tax on Individuals Amendment

Description: Prohibits the state from levying an income tax on individuals

A “yes” vote supports this amendment to prohibit the state from levying an income tax on individuals.

A “no” vote opposes this amendment, thus continuing to allow the state to enact a tax on individuals in the future through a statewide referendum.

PLEASE NOTE: The proposition is only to help ensure that we don’t ever have a state income tax.. A YES vote supports adding verbiage to the Texas constitution that will make it harder for future legislatures to give us a State tax.

Sen. Pat Fallon explains:

“We are banning the possibility of a state income tax. If this measure fails we will NOT have an income tax in Texas. Right now all it takes to have an income tax imposed on folks is to get a simple majority of both the House and the Senate and then a simple majority of the voters and we’d have an income tax in Texas. By passing this measure and amending the constitution we would change this to a 2/3 majority vote in both the House and Senate and then voter approval. We are essentially raising the bar considerably.”

PROPOSITION 5:

Sales Tax on Sporting Goods Dedicated to Parks, Wildlife, and Historical Agencies Amendment

Description: Dedicates revenue from the sales tax on sporting goods to parks, wildlife, and historical agencies

A “yes” vote supports this constitutional amendment to dedicate revenue from the sales tax on sporting goods to the Texas Parks and Wildlife Department and the Texas Historical Commission

A “no” vote opposes this constitutional amendment, thus allowing the legislature to decide how much of the revenue from the sales tax on sporting goods is allocated to the state Parks and Wildlife Department and the state Historical Commission

PROPOSITION 6:

Cancer Prevention and Research Institute Bonds Amendment

Description: Authorizes the legislature to increase bonds for the Cancer Prevention and Research Institute

A “yes” vote supports this amendment to allow the legislature to increase the maximum amount of bonds for the Cancer Prevention and Research Institute of Texas from \$3 billion to \$6 billion.

A “no” vote opposes this amendment, thereby keeping the maximum amount of bonds for the Cancer Prevention and Research Institute of Texas at \$3 billion.

PROPOSITION 7:

Increase Distributions to School Fund Amendment

Description: Increases distributions to the state school fund

A “yes” vote supports this amendment to increase the amount of revenue from \$300 million to \$600 million that the land board is permitted to transfer from the permanent fund to the available school fund each year.

A “no” vote opposes this amendment, thereby keeping the amount of revenue that the land board is permitted to transfer from the permanent fund to the available school fund each year at \$300 million

PROPOSITION 8:

Flood Infrastructure Fund Amendment

Description: Creates a Flood Infrastructure Fund

A “yes” vote supports this constitutional amendment to create the Flood Infrastructure Fund, which the Texas Water Development Board would use to provide financing for flood drainage, mitigation, and control projects

A “no” vote opposes this constitutional amendment to create the Flood Infrastructure Fund

PROPOSITION 9:

Precious Metals in Depositories Exempt from Property Tax Amendment

Description: *Authorizes property tax exemption for precious metals held in depositories*

A “**yes**” vote supports this amendment to allow the **legislature** to exempt precious metals held in precious metal depositories from property taxation

A “**no**” vote opposes this amendment, thereby continuing to permit taxation of precious metals held in precious metal depositories as property

PROPOSITION 10:

Transfer of Care of Law Enforcement Animals Amendment

Description: *Allows for transfer of law enforcement animals to handlers or others if in animal’s best interest*

A “yes” vote supports this amendment to allow for the transfer of a law enforcement animal, such as a dog or horse, to the animal’s handler or another qualified caretaker if the transfer is in the animal’s best interest.

A “no” vote opposes this amendment to allow for the transfer of a law enforcement animal, such as a dog or horse, to the animal’s handler or another qualified caretaker if the transfer is in the animal’s best interest
